Leveraging the Potential of Cities in P/CVE: The Role of Mayors and other Local Leaders in Implementing the UN Global Counter-Terrorism Strategy

Concept Note

OVERVIEW

On 23 June 2023, the <u>Strong Cities Network</u> and European Union will co-host a 90-minute side-event during the <u>UN 2023 Counter-Terrorism Week</u>, which will allow mayors and other local leaders to share experiences, good practices and challenges with preventing and responding to violent extremism in their communities. It will also highlight practical steps for enhancing the role of these important preventing and countering violent extremism (P/CVE) stakeholders in UN and other multilateral dialogues focused on addressing the dynamic violent extremist threat environment.

Among the event's objectives include increased awareness among Member States and <u>UN Global</u> <u>Counter-Terrorism Compact</u> entities of a) the contributions that mayors and other local leaders can make to whole-of-society P/CVE efforts, including through facilitating the localized implementation of the <u>UN</u> <u>Global Counter-Terrorism Strategy</u> (UNGCTS) and relevant national frameworks; and b) the added-value

of including the voices of local leaders and the perspectives of cities in multilateral conversations around the formulation of P/CVE policies and the development of P/CVE programs.

BACKGROUND

Cities have a number of often overlooked comparative advantages in P/CVE. These are based on cities (whether big or small or urban or rural) proximity to and understanding of local communities, the trusted relationships they have developed with them as a result of their traditional service delivery responsibilities, and how local governments are well-positioned to identify and defuse inter-communal tensions and address local socio-economic grievances before they manifest in extremist violence.

Given the highly localized nature of violent extremist threats, which are increasingly driven by local grievances, it is critical that national and multilateral P/CVE efforts reflect the voices of local leaders so that these efforts can be translated into effective and sustainable local action.

To-date, important progress has been made in operationalising the whole-of-society approach to addressing terrorism and violent extremism enshrined in the UNGCTS and the UN Secretary-General's <u>PVE Plan of Action</u>. However, the potential of mayors and local governments have remained largely untapped. This is due to a number of factors, including that overly centralized and securitized approaches to these challenges remain predominant.

The Strong Cities Network, including with support from the EU's <u>STRIVE Cities initiative</u>, has been working with local leaders and governments around the world to overcome the barriers to more city-led P/CVE efforts and allow local governments to tap into their full potential as leaders in prevention.
